 - A. Contract Renewal: Comprehensive LAN Management Agreement with Computer View Inc. (CVI). WPLD has maintained a working relationship with CVI since 1996. The proposed agreement covers the comprehensive management of installed inventory of 221 devices for two years (July 1, 2022 to June 30, 2024). The charge for the first 12 month term is \$77,200, and for the second 12 month term is \$81,200. The current agreement with CVI covers the comprehensive management of installed inventory of 176 devices for two years (July 1, 2020 to June 30, 2022) for a current annual charge of \$65,900.
