- I. Call to Order and Roll Call. President O'Laughlin called the meeting to order at 7:33pm. She thanked the Library directors and staff for all of their work. Both trustees O'Laughlin and George stated that they are proud of the Library and that they wish the incoming trustees the best in their new roles.

- IV. Public Comment. Elaine Fandell thanked trustee O'Laughlin for her 20 years of service to the Library. She stated that the entire community of Wilmette owes trustee O'Laughlin its gratitude and that the Library has grown tremendously during her tenure on the WPL Board.
- V. Treasurer's Report.
 - A. Notes on Financial Reports for March. Treasurer Rodgers summarized the March financial reports. The two largest sources of General Fund revenue were from Real Estate Taxes and the Kenilworth Public Library. Total General Fund March expenditures were 71.15% of budget; the nine-month expenditure rate was 75.00%. The largest General Fund check was written to Wellness Insurance Network.

VII. Discussion Items.

- A. Outdoor Renovation Project Update. Director Auston stated that WPL received the village permit on April 12 and that site preparation has begun. He reviewed project activities for the upcoming weeks, which primarily will involve the hardscape. Project overview materials and fact sheets are on display in the vestibule.
- VIII. Director's Report. Monthly statistics and other information were included in attachment 5 of agenda binders. Director Auston reviewed the report and stated that Strategic Plan status reports will be included in future Director's Reports. Director Auston encouraged trustees to participate in American Creed and One Book Everybody Reads (OBER) activities. WPL book drops located at the Recreation Center, Plaza del Lago, and the Linden CTA station will have new vinyl wraps. Trustees will be notified regarding installation of the Linden CTA book drop. He distributed OBER bookmarks and contest winning Youth Services bookmarks. The Friends have donated \$31,000 to WPL this year and the Director stated that both staff and trustees are very grateful for the Friends' continued support. The new president of the Friends is Mary Ann O'Keefe.

IX. Committee Reports.

- A. ILA Representative. ILA newsletters received after the last WPL Board meeting have been emailed to all trustees. Trustee Barshis summarized the newsletters and other articles of interest.
- B. Finance Committee. Chair Rodgers summarized the Monday, April 15, 2019 Finance Committee meeting at which the budget for the next fiscal year was reviewed.

X. Information Items.

- A. At the April 2, 2019 consolidated election, Jan Barshis, Joan Fishman, Lisa McDonald and Maria Josefina Cannon-Riddle were elected to the Wilmette Public Library Board of Trustees. All of the positions are for full four-year terms expiring in April 2023. Elected trustees will be sworn in, officers (WPL Board president, vice-president, secretary, treasurer) will be elected, and the new WPL Board will conduct all business at the May 2019 meeting. The president announces committee and trustee assignments to committees at the June 2019 meeting.

- D. WPL has been awarded a FY2019 Illinois Public Library Per Capita Grant of \$33,858.75. As stated in the letter from Jesse White, Secretary of State and State Librarian, "Please be aware that due to the continued payment backlog, these funds may be significantly delayed. As in previous years, the library may use these funds until the end of the following fiscal year; in this case, until June 30, 2020." The FY2018 Illinois Public Library Per Capita Grant was for the same amount, \$33,858.75.
- E. The Library will be closed Sunday, April 21, 2019 for Easter.

- F. On Sunday, May 5, 2019 at 2:00 pm Rosellen Brown will discuss her novel *The Lake on Fire* at the Wilmette Junior High School, 620 Locust Road in Wilmette. *The Lake on Fire* is The One Book, Everybody Reads (OBER) selection for 2019. The novel is set in Chicago during the 1893 World's Columbian Exposition. The author event is funded and sponsored by the Friends of WPL. Go to www.wilmettelibrary.info/onebook for OBER events.
